THE PROGRAM OFFERS CLIENTS SAFE EMERGENCY SHELTER, MEDICAL AND LEGAL ACCOMPANIMENT, ADVOCACY, CRISIS INTERVENTION AND A 24/7 CRISIS HOTLINE. THE CENTER HAS TWO SATELLITE OFFICES THAT PROVIDE CASE MANAGEMENT IN MID-COUNTY AND IN NORTHERN COUNTY TO BETTER SERVE SURVIVORS. DURING THIS FISCAL YEAR, THE PROGRAM RECEIVED APPROXIMATELY 4,720 CRISIS HOTLINE CALLS AND PROVIDED 12,306 SHELTER BED NIGHTS TO SURVIVORS.
